So What is Covered?

- **Personal Injury & Property Damage** claims arising from the performance of Professional Services by the insured in respect of a specific project
- **Defence Costs Paid in Advance** prior to final resolution of a valid claim
- **Loss of Documents** first party cover for replacement and restoration costs
- **Defamation** including unintentional libel, slander and injurious falsehood
- **Vicarious Liability** resulting from the actions of the insured's agents

Optional Extensions

- **Principal's Indemnity** for loss the principal is legally liable to pay for in respect of a claim resulting from an act, error or omission of the insured
- **Loss Rectification & Mitigation** - direct costs and expenses incurred in taking action to rectify or mitigate the effects of any act, error or omission that would otherwise result in a claim covered under the policy
- **Intellectual Property Rights** - for unintentional breaches excluding North America
- **Fraud & Dishonesty** (no cover for the guilty party or for loss of money)
- **Professional Inquiries** which have the potential to lead to a claim
- **Pollution** - for claims in respect of sudden and accidental pollution exposures
- **Consequential Loss** for consequential losses flowing from property damage
- **Pure Economic Loss** for consequential losses which do not flow from personal injury or property damage

What is Excluded?

- **Contractual Liability & Commercial Risks** unless such liability would have attached in the absence of the contract
- **Fraud & Dishonesty** - cover is available for innocent persons under the F&D Optional Extension
- **Intellectual Property Rights** - cover is available under the IP Rights Optional Extension
- **Pollution** - cover is available under the Pollution Optional Extension
- **Jurisdiction** cover is limited to the jurisdictions nominated in the schedule
- **Consequential Losses** - cover is available under the Consequential Loss and Pure Economic Loss Extensions
- **Other Exclusions** include Employer's Liability, Prior Matters, Related Parties, Owners & Occupiers Liability, Aircraft & Watercraft, War, Terrorism & Nuclear, Asbestos, Product Defects & Recall, Licensing Inquiries and Retroactive Limitation.
